{Policies}

1. A non-refundable session fee is due within 10 days of booking your date. This guarantees the time and date allotted for you. Should payment not be received in this time frame, I reserve the right to offer the date and time to another client. You may transfer your session fee to another date if you wish.
2. Session fee does not include prints.
3. No part of any order, including previews, will be delivered until the balance is paid in full.
4. If I cannot perform this contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to my illness or emergency, then I will return any deposit or session fee to the you but we have no further liability with respect to the contract. This limitation on liability also applies in the event that photographic materials are damaged in processing, lost through camera or media malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of me. In the event I fail to perform for any other reason, I will not be liable for any amount in excess of the retail value of your order.
5. You are aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and you release me from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
6. The charges in this Contract are based on my Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
7. Returned checks are subject to a \$35.00 returned check fee. You assume responsibility for any and all collection costs and legal fees incurred by Stephanie McFrederick and/or Stephanie McFrederick Photography in the event of enforcement of this contract becomes necessary.
8. This Contract incorporates the entire understanding of the parties. Any modifications of this contract must be in writing and signed by both parties.
9. Please only bring the people that will be photographed to the session. This eliminates unnecessary distractions and chaos.
10. You are allowed up to 4 people for your session. There is an additional fee of \$10 per additional persons.
11. Your final portrait order will be delivered approximately 1-2 weeks after your order is placed. Canvases, storyboards and custom designed products and specialty items may take up to 4-6 weeks. I will contact you by phone in order to set up a convenient time for your images to be delivered.
12. Handle your portraits with extreme care. Damage incurred as a result of improper handling, framing or hanging is the responsibility of the client.

13. Due to the custom nature of each session, all sales are final and once the order has been placed, there are no refunds
14. Copying these images in any way is illegal. If you would like a disc of low resolution for email, blogs, or other Internet usage you may purchase it for \$25. These are non-printable watermarked images and may only be used for Internet usage.
15. Online proofs will be displayed for 30 days. If you need longer then 30 days, a \$25 fee is required to keep them up for 2 weeks.
16. If I feel the images from our session does not reflect my work a re-shoot will be issued. A re-shoot may also be necessary if I feel the child is not acting their best. This is for your own benefit to ensure that you receive the best portraits possible. This rule does not apply for cranky dads!
